### Who is Behind the recall?

In 2018, former School Board President Aurora Villon decided not to run for re-election. Why? She wanted to be appointed to the \$240,000 a year superintendent position. But her candidates running for school board to make this happen lost - convincingly. 9200 to 3400 votes. Pico Rivera spoke loud and clear. Now a new board majority exists in Pico Rivera. A bold majority that won on the campaign promise to rebuild the Ranch!

The Pico Rivera community has come together and formed this group to continue fighting for our children, The recall proponents are using the retirement and demotion of two long time administrators to get signatures. Matthews and his \$229,000 annual salary never reprimanded Greg Salcido before he was fired by the board. The other one, Genis, the highest paid principal in Pico at \$187,000 a year, ran an underperforming school for years - verified by state rankings. Genis was appointed by his brother who was Superintendent at the time. Being a 2 out of 10 does not merit such pay.
